A man who suffered with low self-esteem for years has trained to be a hypnotist to help solve other people's problems.

MP bids for fairer funding

MP JIM Paice is assuring residents he is fighting for fairer funding for schools in Cambridgeshire.

The South East Cambridgeshire MP says Cambridgeshire is the fastestgrowing region in the UK and it needs to make sure the county's educational infrastructure can keep up with the growth.

He said: "For many years now Cambridgeshire has received a much lower level of funding than most local authorities.

"Last year each pupil in Cambridgeshire received £438 less per year than the national average as the result of historical accident and an out-of-date assessment of need.
